- A Tender was floated on 17/08/2016 for "Procurement of DBS collection Consumables". Tender Ref. No- NACO/Proc./01/2016. A pre-bid meeting was held on 30 Aug 2016 at 2.15 pm at 9th floor, NACO and the tender was opened on 20/09/2016 at 14:15 Hrs.
- 2. The Committee examined the Tender. The Committee noted that a total number of 3 bidders have submitted their bids as under:
 - M/s GSR Health Sciences. Bangalore
 - M/s Shivam Enterprises. Ahmadabad
 - M/s Kornish Surgicals, Ahmadabad
- In the technical evaluation only two bidders have qualified i.e. (i) GSR Health Sciences and (ii) Shivam Enterprises. Kornish Surgicals (i.e third bidder) was disqualified in the technical bid so price bid was not opened.
