Eligibility criteria for inclusion of high risk individuals in HSS

Inclusion criteria

- Fulfill the case definition
- Age between 15 & 49 years

Exclusion criteria

• Already approached and administered informed consent once in the current round of surveillance

Case Definitions

- Female Sex Worker: Woman who is engaged in consensual sex for money or payment in kind, as a means of livelihood in the last 6 months
- Men who have Sex with Men: Man who had anal or oral sex with a male partner in the last one month
- Injecting Drug User: Man or woman who used addictive substances or drugs for recreational or non medical reasons, through injection, in the last three months
- Transgender/Eunuch: Person whose identity does not conform unambiguously to conventional notions of male or female gender roles, but combines or moves between these
- his spouse or family, for the purposes of work and visiting his home town at least once a year

• Single Male Migrant: Single Male, living at a place other than "place of usual residence" without

• Long Distance Trucker: Trucker who travels more than 800 km one way between source and destination





Recruitment Process by Random Sampling



Processing Dried Blood Spot (DBS) Specimens


Check for completeness of data form before specimen collection. If incomplete, send back to counselor to complete the form. Label the filter paper card with sentinel site code, sub-site number, sample number and date of collection before starting blood collection.




Select 3rd of 4th finger to prick



Collect 5 blood drops on filter paper card. Ensure each circle is completely filled.




Choose correct puncture site



Place filter paper card horizontally in drying rack with blood spots facing outside. Allow to dry overnight in drying box with 5 desiccants at the bottom.



Clean finger tip with alcohol swab



Completely dried DBS specimens appear chocolate brown in colour



Make finger prick using self-retractable safety lancet



Fold butter paper over **DBS** specimen



Wipe away the first drop



Allow a large drop of



Place DBS card inside small zip-lock bag. Add 2 desiccants behind the DBS card.



Pack up to 10 small zip-lock bags with DBS specimens in a big zip-lock bag. Add 5 desiccants.

Pack big zip-lock bag containing DBS specimens inside the Sample Transportation Box along with 2 copies of Sample Transportation Sheet. Send DBS specimens to the designated testing lab by Speed Post or Courier, whenever TEN specimens are collected and completely dried or at the end of the week, whichever is earlier.
